1. Informations for Non-EU foreign citizens



Foreign citizens can enter in our territory for tourism, study, family rejoining and work.

The foreign citizen can enter in Italy if he can document the reason and the conditions of the stay, other than the availability of means both for living during the stay and for going back to his Country, except in case of working reasons.

Who does not meet these requirements or is considered a threat for National security or for security of one of the Countries Italy has signed an agreement with for free circulation of people across the internal frontiers can not enter Italy. The reference legislation about immigration and the condition of the foreigner is the Immigration Text (*Testo Unico sull'Immigrazione*).

1.2. Regular stay: required documents

For regularly entering Italy you need passport or any other travel document and an entry visa (for visit and/or tourism, for work, for study and/or research, for family, etc.), to ask to Italian embassy or consulate in the native Country or at the Non-EU foreign citizen's permanent residence. The entry in Italy is allowed with visa for short stays, valid until 3 months, and for long stays, that needs a permit of stay (of long duration) with the same reason of the visa. For less than three months stays are considered valid visa issued by diplomatic authorities of other Countries, which Italy has agreements with, or according to comunitarian rules.



1.3. Irregular presences and expulsions

Non compliance with these procedures, or a stay more than 3 months or the lower end eventually stated on visa, puts the foreigner in a condition of irregular, and it involves the expulsion, except for cases of force majeure provided by law. The expelled foreigners can not come back to Italy, except if they have a special permission or the entry interdiction is finished. Foreigners who have been reported for serious reasons of public order and national security, and of preservation of international relations are not allowed to Italy. Actually, is considered irregular:

- The Non-EU foreign citizen, who enters to Italy without documents (passport or ID document and visa);
- The Non-EU foreign citizen, who, regularly entered to Italy, has lost the necessary requirements for staying.

The foreigner, who irregularly comes to Italy, is sent back to the border or, if he is already inside the national territory, is expelled, unless he has to be held in one of the immigration centres for verifying identity and/or nationality. The measure of expulsion is taken by the competent Prefecture (Prefettura) and it is executed by the Police Headquarters (Questura).

1.4. Entry for work

The entry to Italy for employment, even seasonal employment, and self-employment, has to take place within the entry quotas (article 21 T.U.), defined inside the periodical decrees (usually yearly), known as "flow-decrees", issued by the Prime Minister on the criteria of the three-year programmatic document about immigration politics (article 3). The flow-decrees generally provide some quotas for citizens, who come from countries, which the State has agreements with for the regulation of flows and readmission procedures.

1.5. Immigration Office

It is the location, present in every Prefecture, competent for:



- The issuance of authorisation for getting an employment, fixed-term or permanent, and seasonal employment of Non-EU foreign citizen, resident abroad, within the quotas of the "flow-decree";
- The issuance of authorisation for getting an employment in particular cases (artt. 27, 27 bis, 27 ter and 27 quater of D. LGS 286 of 1998 (*Testo Unico Immigrazione*));
- The issuance of authorisation to entry of foreign citizen for family rejoining;
- The conversion of Permits of Stay for study or seasonal training into permit for work.

1.6. Clearance for foreign workers' employment

The employer, through an online procedure on Internal Ministry website, asks for the clearance to the immigration office of the province, where the job has to take place. The immigration office, got the approval by the Police Headquarter and by the Work Local Direction, with all requirements, issues the clearance.

1.7. Clearance for family rejoining

The foreign citizen, who is regularly in national territory with a permit of stay with a validity not less the one year, can ask to the immigration office the clearance for family rejoining with:

- Not legally separated spouse of legal age;
- Not married minor children, with other parent's consent;

- Adult dependant children (for total disability);
- Dependant parents, if they have not any other children in their country, or over 65 years old parents with other children, who can not take care of them for serious health reasons.

1.8. Permit of stay conversion

The foreign citizen, who regularly stays in national territory with a valid permit of stay for study, training or seasonal work, can ask for the conversion to the province immigration office, where he has the residence, for verifying the availability of entrance quotas for work.

2. System of reception on the territory

Alongside migration policies, in our Country there is a reception system based on two levels.

On one side there is the first reception right after landing in the hotspot – and for the time necessary for the first material and sanitarian assistance, together with identification and photo-signaling – as well as, later, inside centres opened by Prefecture on the whole national territory, where are given the main services, waiting for the definition of international protection request.



The second reception is ensured by project of assistance to the person and of integration in the territory, activated by the local authority, that are inside the System of protection for international protection holders and unaccompanied foreign minors (SAI). For this purpose, the local authorities can use foundings given by the Internal Ministry through the national Fund for asylum services and politics.

The protection System is characterized by:

- The local authorities' voluntary participation to the reception projects network;
- Synergetic politics on the territory with non-profit operators, who support in an essential way to the realization of the actions.



The reception projects, presented through public applications, are evaluated by a Commission, composed by Internal Ministry representatives, by one representative of Italian Municipalities National Association (ANCI) and by one representative of the Union of Italy's provinces (UPI). Then, there are one representative of the United Nations High Commissioner for Refugees (ACNUR) and one representative of Regions.

The Internal Ministry gives specific guidelines, where are specified criteria and procedures for local authorities for applying until the annual distribution of the national Fund for asylum services and politics.

4. The Municipality

Inside juridical system of Italian Republic, a **Municipality** is an independent territorial local authority established by the Italian Republic's Constitution.

The **Mayor** is the chief of Municipality. He is democratically elected through local elections by universal suffrage among all local citizens, who have right to vote (resident with age over then 18). The mayor has executive powers with **the municipal council**, a collegial organ composed by a variable number of comunal **councilors**, named by him, who represent the political forces that support him. The mayor administration lasts 5 years, unless dimissions or death.

The **city council**, a collegial organ equal to the Parliament at a statal level, is composed by councilors, who represent all the local political forces. The **councilors** have the task to: vote the city budget, deliberate and approve a measure issued by the mayor and/or council (an example are the Orders). Other then assessor and counsellor, there is the **City Clerk**. The administrative work usually takes place inside the **Municipality**, the place for the direct relations with citizens.

The Municipality is responsible for the administration of the territory as regards:

- Definition and respect of annual city budget
- Definition and respect of municipal general town plan
- Public order and public security
- Management of municipal streets viability
- Management of public buildings
- Waste disposal
- Management issues for bad weather and natural calamities.

Every municipality belongs to a **Province**. That is a local authority with a competence over a group of municipalities. The **Region**, instead, represents the first level of division of the territory of the Italian State with functions defined by Constitution.

Every Region has at least one province. In fact, the **Region of Basilicata** includes **Province of Matera** and the Province of Potenza. The citizen can ask to the Municipality for civil declarations and civil state certificates, issued by Municipalities.

These documents are about facts or events concerning the life of citizen, as for example:

- A child's birth and recognition
- Identity card issuance
- House, address or residence chagement
- Transfer of residence from another Municipality or abroad, but even transfer of residence to abroad
- Constitution of a new family or a new cohabitation after marriages, civil unions, de facto cohabitations and divorces
- Death of a family's member



Then, it is possible to go to the **municipal Library**, in Eraclea square, for:

- Books, newspapers and magazines' free consultation;
- Book's free loan;
- Documents reproduction;
- Internet service;
- Computer stations for visually impaired;
- Ask for school canteen food vouchers;
- Ask for school transport (schoolbus).

4.3. The Local Police



The local police (or municipal police or traffic police) is a kind of local police, that in Italy works for ensuring urban security. The local police is managed by the municipality, so the main authority is the mayor. The local polices have duties of public administration. These contribute to preserve public order and public security, together with the national police.

The local Police takes mostly action for checking urban viability and for situations of urban decay, trafficking, fights, robberies, predatory crimes and many other disorders. Among the functions there are: public security; administrative police; vigilance on local rules' respect; services of annonaria and commercial police; environmental, sanitarian and local tax police; traffic police (inside the competent territory, unless agreements and authorizations of national authorities).

5. The Healthcare Services

The national health Service (SSN) is a system of facilities and services for guaranteeing to all citizens, in conditions of equality, the universal access to an equal granting of the health services, according to the art. 32 of the Italian Republic's Constitution.

Every Region has its own health system. Basilicata has two local health companies, that line up the two provinces: Matera and Potenza.

The Hospital is the organizational structure for promotion, preservation and recovery of health conditions of the population giving diagnosis and care through specialistic facilities of hospitalization or outpatient service.

5.5. The Emergency

The **Emergency** is an operative hospital unit, responsible for cases of emergence-urgency. It is in every local hospital: Policoro (0835.986312), Tinchi (0835.586525), Matera (0835.253212).

6.The Police Forces

Italian Police forces are forces, who oversee the performance of Police functions inside the Italian Republic.

Italian law includes 4 national Police forces at a direct governative control (civil and military), other then local Police, that can be formed by municipalities (or groups of municipalities) and provinces.

All State army corps have public security and judicial Police functions, but these are both different from typical Police function.

6.1. The State Police

The State Police is under the Department of Public Security of the Internal Ministry, with functions of judicial and administrative Police. The main function is public security and order management.

6.2. The Penitentiary Police

The penitentiary Police is dependant by the Justice Ministry, with competences specialized in services about the management of people under restrictions of personal freedom and of prisons, functions of judicial police, of prevention, of traffic police, (regarding to the institute's tasks) and of public order.

6.3. Carabinieri

To the harbour offices are historically assigned the discipline and the supervision above all the port and sea activities.

Among the main competences there is the safeguard of human life in the sea, the security of navigation and of the sea transport, other than the protection of the sea environment, his ecosystems and the activity of supervision on the sea fishing, from the protection of resources untill the final consumer. To these it needs to add the inspections on the commercial national fleet, for fishing and for recreational, done even on foreign merchant ship, that scale the national ports. 7.2. INPS

INPS almost manages the totality of Italian pension, ensuring most independent workers and employers of private and public sector.



INPS manages liquidation and payment of pensions and welfare and social benefits. The pensions are social security benefits, fixed on the basis of insurance relationships and financed with workers and private and public companies contributions. Instead, the assistance benefits or "the income support" protect workers, who are in particular hard moments of their working life, and pay amounts to those who have modest income and

to large families. For some of these benefits INPS is involved only in the pay-out phase, but for the others it follows all the process of attribution.

INPS even governs the database for calculating the ISE, used by Municipalities for giving child and maternity benefits, and the ISEE, for getting some social benefits.

7.3. INAIL

Inail, National Institute of Insurance against Accidents at Work, is a public not economical organization, that manages the compulsory insurance against accidents at work and professional illness. 9. Schools and professional training

The educational and training Italian system is organized under principles of subsidiarity and schools autonomy. State has the only law competence for “general laws about education” and for the determination of basic levels of benefits to guarantee on all national territory.

The state educational institutions have an educational, organizational and of research, experimentation, development autonomy.

The educational system is organized as following:



Integrated system zero-six years old, not compulsory, of a total duration of 6 years, divided in:

- Educational services for childhood (commonly called “nurseries”), managed by local Authorities, directly or through agreements, or by other public organizations or by privates, who receives babies between three and thirty-six months;
- Pre-primary school (even called “asilo” or “scuola materna”), that can be managed by State, local Authorities, directly or through agreements, or any other public organizations or privates, who receives babies between three and six years old.

First education cycle, compulsory, of a total duration of 8 years, divided in:

- Primary school (ex elementary school), of five years, for pupils from 6 to 11 years old;
- First grade secondary school (ex low junior school), of three years, for pupils from 11 to 14 years old.

Second cycle of education is divided into two types of courses:

- Second grade secondary school (ex high secondary school), of five years, for students, who have positively concluded the first education cycle. Schools organize courses of lyceum, technical institutes and professional institutes for students from 14 to 19 years old.

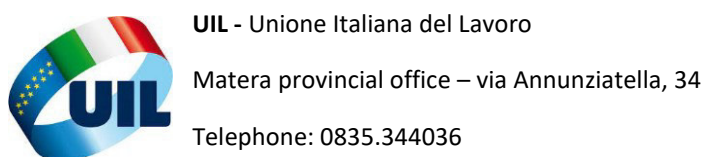
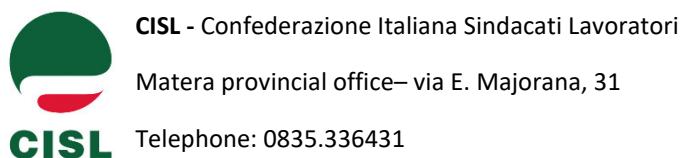
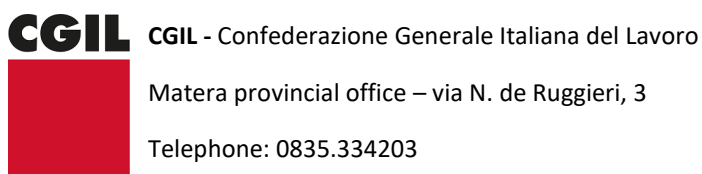
